



"Korea and the OECD" Conference in Commemoration of the 10th Anniversary of Korea's Accession to the OECD

September 21-22, 2006 Lotte Hotel, Seoul, Korea

Korea will mark the 10th anniversary of its accession to the OECD as the 29th member on December 12, 2006. The present conference has been intended to commemorate this anniversary. The Korean government and the OECD have worked together to prepare for globalization as value partners during the last 10 years. This conference will shed light on how Korea has benefited from its membership to the OECD in the immediate aftermath of the 1997 crisis. Now that Korea is completely recovered from the crisis and positioned itself to assume more of an active role in the globalized economy, a new type of partnership will be needed. This conference will provide an opportunity to assess past achievement in Korea-OECD cooperation and to create a new partnership for the next decade in response to the new challenges of globalization.

SESSION 1:

"Korea, Then, Now and the Future"

(Chair : Dr. Soogil YOUNG, President, National Strategy Institute)

Korea's rapid post-crisis recovery has lifted its per-capita income to two-thirds of the OECD average. The Korean economy is changing profoundly as a result of the structural reform programme launched after the 1997 crisis, and also as a result of increasing integration into the world economy. The OECD has played a vital role in this process as a pioneer pathfinder and partner. The key long-term challenge is to continue the rapid increase of Korea's income level to the average income level in the OECD area by accelerating productivity growth, as inputs of labor and capital slow down. This session will make a stock-taking of the past 10 years of OECD membership and the progress made in economy and other reform. It will also discuss the future direction of Korea toward a dynamic and a more mature economy, in close cooperation with the OECD.

While Globalization provides an opportunity for an ever-growing prosperity, it also poses potential risks. After having successfully—recovered from the crisis and upon entering the new Millennium, such issues as the aging population and the subsequent pressure on welfare as well as the phenomenon of aggravating income polarization have emerged in the Korean society. These challenges, while new in the Korean context, have already been dealt with by the OECD. During this session, discussion will focus on the ways to relieve polarization by sharing benefits of globalization, and by groping and shaping a Korean socio-economic model, underpinning the need to maintain economic vitality while safeguarding social cohesion severely enfeebled through the process.
