# People-to-people exchange in the STEM field

At the May 2021 summit, the two presidents agreed to further increase mutual investments and R&D cooperation on supply chains and emerging technologies. On this occasion, leading ROK companies announced significant investment plans to build semiconductor and EV battery plants in the US. The two countries are also exploring R&D cooperation in such areas as 6G, open-RAN, space, and bio and quantum technologies. A secure and sustainable environment for innovation and economic resilience requires greater interaction between experts and the public from both countries. In this session, we will discuss (1) Assessment of the current bilateral STEM exchange programs, (2) Proposals from the private sector for nurturing and expanding STEM talents in both countries through exchange programs, and (3) Possible administrative and legislative approaches to enhance people-to-people exchange in the STEM field.
